## **Interview Process**

After receiving the completed application and facilitation video, the internship coordinator will contact you to set up an in-person or virtual interview, depending on the applicant's location. The interview is composed of questions related to background and prior experience. The interview includes a case study and you will be asked to facilitate a few interventions on a variety of instruments. After the interview, the internship coordinator will be available for any additional questions. Therabeat, Inc. accepts 1-2 interns per training term. Upon acceptance to the internship, a legal affiliation agreement between the student's university and Therabeat, Inc. is required. Interns will not be able to start their internship until this agreement is complete.

# **General Internship Outline**

The intern and advisor will set up a working daily schedule together at the start of the internship. The intern will complete the hours from direct observation of Music Therapy and other disciplines within the clinic, as well as other sites as deemed appropriate by the advisor. The intern will be responsible for session plans, data, and documentation for each session. After an agreed upon duration of observation and co-leading, the intern will begin leading sessions independently with advisor supervision. Case studies, data collection, assessments and evaluations will also be part of internship experience. However, one of the most beneficial assets of this internship is that the intern has many opportunities for professional development. The music therapy intern will have the opportunity to observe therapists of other disciplines as well as participate in co-treating patients with various abilities. Other opportunities for professional growth may include participating in presentations about music therapy at conferences and other relevant places in the community.
